### POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 9 SEPTEMBER 2024

The Board is pleased to announce that at the AGM held on 9 September 2024, all the Resolutions were duly passed by the shareholders of the Company or by proxy or by their duly authorized representatives attending and voting at the AGM through the e-meeting system by way of poll.

The board of directors (the “**Board**”) of Chuang's China Investments Limited (the “**Company**”) is pleased to announce that at the annual general meeting of the Company held via a virtual meeting online on 9 September 2024 (the “**AGM**”), all proposed resolutions (the “**Resolutions**”) were duly passed by the shareholders of the Company or by proxy or by their duly authorized representatives attending and voting at the AGM through the e-meeting system by way of poll.

The full text of the Resolutions were set out in the notice of the annual general meeting dated 25 July 2024.

As at the date of the AGM, the total number of issued shares of the Company was 2,347,035,316 which was the total number of shares entitling the shareholders to attend and vote on the Resolutions at the AGM. There were no shares entitling the shareholders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no shares requiring shareholders under the Listing Rules to abstain from voting on the Resolutions at the AGM. None of the shareholders has stated their intention in the Company's circular dated 25 July 2024 to vote against or to abstain from voting on any of the Resolutions at the AGM.

The Company's Hong Kong branch share registrar, Tricor Progressive Limited, was appointed and acted as the scrutineer for the vote-taking at the AGM. All directors of the Company attended the AGM. The results of the voting on the Resolutions are as follows:
